1. Kachankawal Rural Municipality invites electronic bids from eligible bidders for the *Construction of 15 Bed Primary Hospital Building* under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.Bidding is open to all eligible as per Section V of bidding document.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 7,50,00,000/-
- Minimum Work experience of similar size and nature: at least 1 building project completed within 1.5 years having value of NRs. 6,00,00,000/-

- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Kachankawal Rural Municipality Office, Baniyani, Jhapa* or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 4. Bidder should submit their bid electronically and may download the bidding documents for e-submission from PPMO's e-GP system www. bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below.

- 5. Pre-bid meeting shall be held at the office of Rural Municipal Executive, Baniyani, Jhapa at 12 Hrs. of 21st May, 2021 (2078/02/07).
- 6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egpon or before 12.00 Hrs. of 6th June, 2021 (2078/2/23). Bids received after this deadline will be rejected.
- 7. The bidswill be opened in the presence of Bidders' representatives who choose to attend at 13:00 Noon of 6th June, 2021 (2078/2/23)at the *Office of Kachankawal Rural Municipality, Baniyani, Jhapa*. Bids must be valid for a period of 120 daysafter bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs. 21,00,000/-, which shall be valid for 30 days beyond the validity period of the bid (*i.e. 120 days from deadline of bid submission*)
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. Other Related rules and regulation are as per Public Procurement Act 2063 and Public Procurement Regulation 2064.
- 10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
